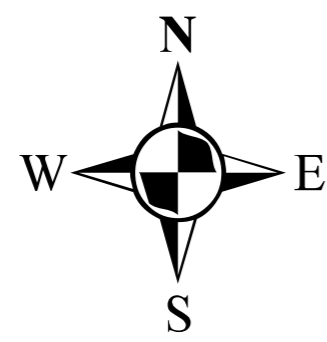


Land Ownership Map Unorganized Towns

Not a legal document.

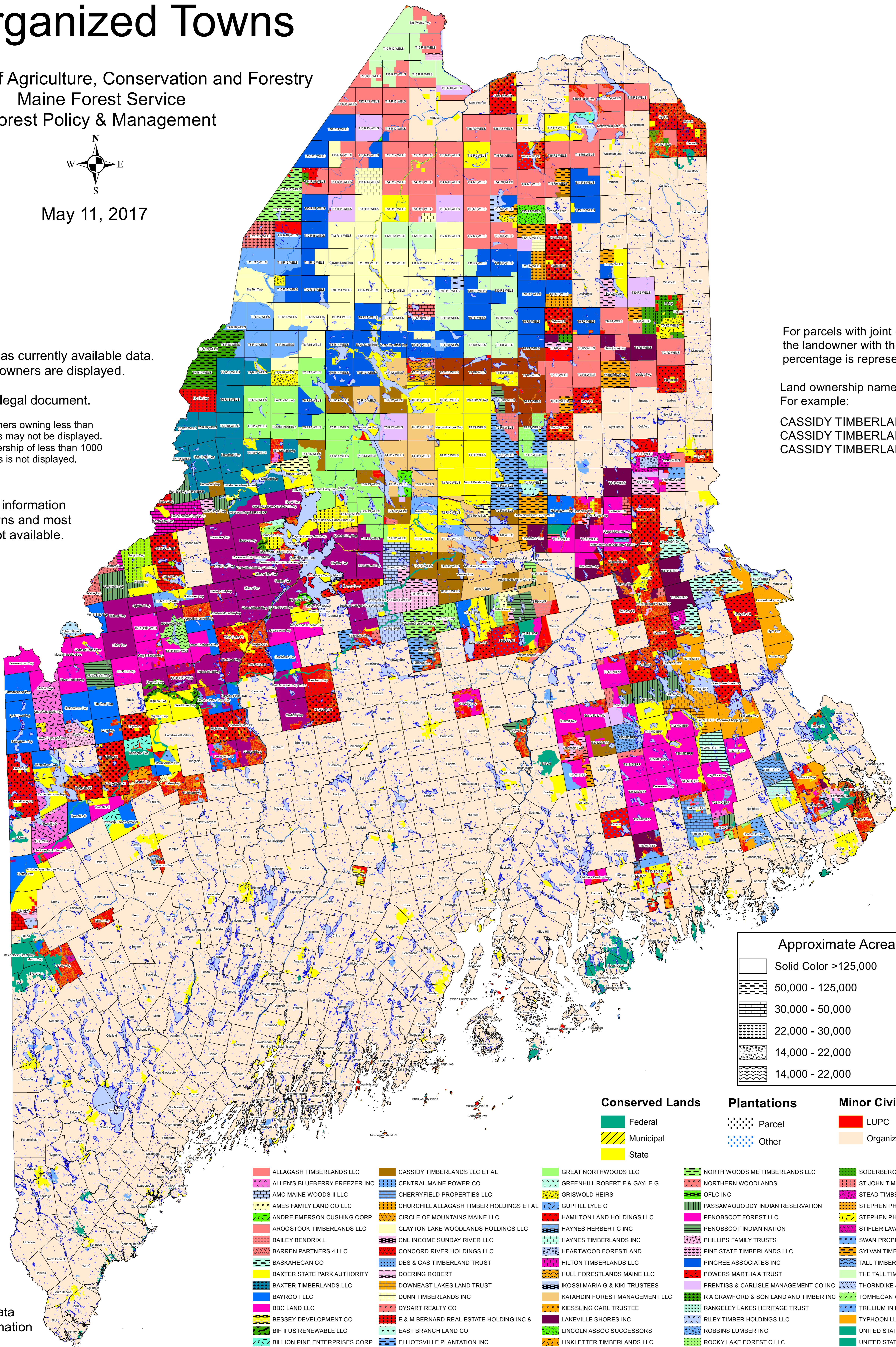
Landowners owning less than
